Important Notice for Our Students: System Updates and Procedural Changes

Dear Students,

We would like to inform you about the recent system updates and procedural changes implemented to enhance the efficiency of our university processes and improve the student experience.

1. Update of the Student Resources Internal Page

Our Student Resources internal page has been renewed!

You can now access up-to-date information regarding your student and academic processes more quickly and clearly, due to the improved structure and simplified content.

Don't forget to visit our internal page to review the updated content.

2. Termination of the Graduation Application

As of the 2025–2026 Academic Year, the "Graduation Application" requirement has been terminated.

Accordingly, all undergraduate and graduate students who fulfill all graduation requirements (completion of all courses, required credits, minimum GPA, etc.) will have their graduation procedures processed automatically, without the need to submit a separate application.

3. Major Declaration and Diploma Program Change for International Students

In line with the new regulations introduced by the Council of Higher Education (YÖK), international students who are admitted to our University from abroad based on their high school GPA cannot apply to diploma programs that require a different type of score and cannot change their registered program.

4. Single Course Exam Regulation

Students who are close to graduation before reaching the maximum period of study but have **only one course remaining**, or those who have completed all course requirements but **have not yet met the Cumulative GPA (CGPA) or Program GPA (PGPA) requirements**, may benefit from the single course exam, provided that they have previously taken the course and fulfilled the attendance requirement, without needing to retake the course.

- Internships, projects, workshops, applied/practical courses, and courses whose assessment cannot be based on a single exam, as well as courses in which students received a "W" or "NA" grade, are excluded from this scope.
- Students may attend for the single course exam only for courses in which they received a grade of C-, D, D+, F, or U.

5. Double Major Program Continuation Requirements

Students who are enrolled in a double major program and are about to graduate from their major program must graduate from their major with a minimum **CGPA of 2.72** in order to continue in their double major program.

6. Minor Programs

The admission, continuation, and completion requirements for all minor programs offered at our University have been standardized. Detailed information is available on our website.

7. Improvements to the Degree Evaluation Form

The *Degree Evaluation Form* has been comprehensively updated. You can now view the courses you have counted, withdrawn from, or failed *separately* by clicking the link located at the bottom of the form, allowing you to track your academic progress in greater detail.

8. Academic Records Summary

With the newly developed *Academic Records Summary*, you can view your academic history, term information, and academic status. In addition, our undergraduate students can easily monitor their academic standing through the academic status assessment feature and quickly access their advisor information.

The renewed **SUTicket** system has been redesigned to significantly simplify the process of submitting requests. Our work to improve user experience in our ticketing system will continue. You may submit all your inquiries and requests related to the Student Resources Unit by creating a ticket through the new **SUTicket** system.
